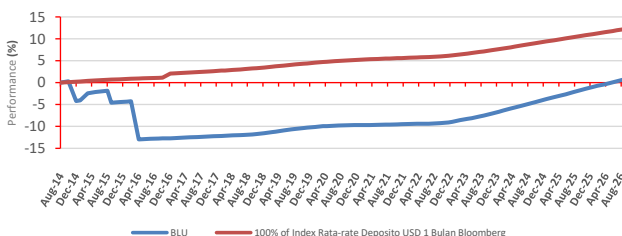

5. Complete the Subscription and/or Redemption Form.

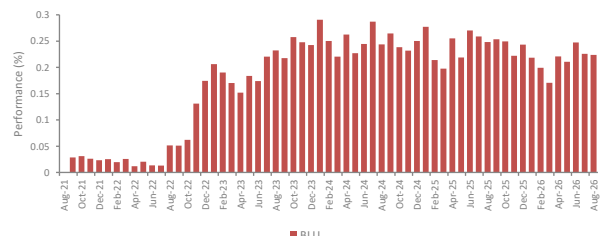
