Warganegara Indonesia. Umur 55 tahun. Beliau mendapatkan gelar di bidang Akuntansi dari Universitas Indonesia dan menyelesaikan program akademik di Universitas Sorbonne di Paris.

Beliau memulai karirnya di industri keuangan sebagai seorang auditor di Price Waterhouse Cooper. Berkembang pesat dengan mengambil posisi penting di beberapa perusahaan multinasional di Citibank NA, Jan Darmadi Group, Niaga Finance, Hong Kong, termasuk Bank Danamon. Pada tahun 1998, beliau kembali ke Indonesia untuk menjadi *Executive Vice President Finance* (CFO) untuk Garuda Indonesia.

Pada awal tahun 2003 beliau diangkat sebagai Deputy CEO Bank Danamon. Kemudian pada tahun 2005, beliau diangkat kembali oleh pemerintah Indonesia sebagai *President & CEO Garuda Indonesia* dan membuatnya sebagai salah satu Pejabat Kepala Eksekutif sebuah maskapai penerbangan termuda di kawasan Asia Pasifik.

Beliau baru saja menyelesaikan masa jabatannya sebagai Ketua INACA (Asosiasi Perusahaan Penerbangan Nasional Indonesia), anggota Dewan Gubernur IATA (International Air Transport Association) dan Ketua Komite Eksekutif AAPA (Asosiasi Asia Pacific Airlines). Saat ini beliau turut menjabat sebagai anggota Dewan Komisaris Bank Muamalat (sejak 2009), Penasehat Senior INACA, dan Wakil Ketua Kamar Dagang Indonesia tentang Perdagangan. Dia adalah *Orient Aviation Person of the Year 2010* (by Orient Aviation Magazine), *Man of the Year 2012* (oleh Globe Asia Magazine) dan *Juara Travel CNBC Leader Business Award 2013* (oleh CNBC) dan baru-baru Asia Pasifik Airline Eksekutif tahun 2014 (oleh Pusat Penerbangan Asia Pasifik / CAPA). Dari segi lingkungan, ia adalah anggota Dewan Wali Amanat dari The Nature Conservancy (TNC), sebuah organisasi yang berusaha untuk menyeimbangkan kebutuhan pertumbuhan populasi dengan orang-orang dari alam.

Indonesian citizen. Age 55. He received his degree in Accounting from the University of Indonesia and completed academic programs at the Sorbonne University in Paris.

He began his career in the financial industry as an auditor at Price Waterhouse Cooper. He quickly assumed key positions in several multinational companies in Citibank N.A, Jan Darmadi Group, Niaga Finance, Hong Kong and Bank Danamon. In 1998, he returned to Indonesia to become EVP Finance (CFO) for Garuda Indonesia.

In early 2003 was appointed as Deputy CEO of Bank Danamon. Then in 2005, he was reappointed by the Indonesian government as the President & CEO of the Garuda Indonesia and makes him as one of the youngest Chief Executive Officers of an airline in the Asia Pacific region.

He has recently completed his tenure as the Chairman of INACA (Indonesian National Air Carrier Associations), a member of the Board of Governors of IATA (International Air Transport Association) and the Chairman of the Executive Committee of the AAPA (Association of Asia Pacific Airlines). He is currently a member of the Board of Commissioners of Bank Muamalat (since 2009), the Senior Advisor of INACA, and the Vice Chairman of Indonesia's Chamber of Commerce. He is the Orient Aviation Person of the Year 2010 (by Orient Aviation Magazine), Man of the Year 2012 (by Globe Asia Magazine) and Winner of CNBC Travel Business Leader Award 2013 (by CNBC) and recently the Asia Pacific Airline Executive of the Year 2014 (by Center for Asia Pacific Airlines/CAPA). On the environmental front, he is the member of the Board of Trustee of The Nature Conservancy (TNC), an organization which strives to balance the needs of a growing population with those of nature.
