It is an API service that provides account mutation information.

3. API Internal Account Inquiry

It is an API service that provides User account information at Danamon banks.

4. Intrabank Transfer API

is an API service that provides transfer services to fellow Danamon bank accounts.

5. External API Account Inquiry

It is an API service that provides the User's account information at other banks.

6. API Interbank Transfer

It is an API service for online transfers to other banks.

7. API RTGS Transfer

It is an API service that provides RTGS transfer services to other banks.

8. API SKNBI Transfer

It is an API service that provides SKN transfer services to other banks.

9. Account Inquiry

It is an API service that provides User account information at other banks for BI Fast.

10. Inquiry Status BI Fast

It is an API service that provides information on the status of BI Fast transactions.

11. API Virtual Account - Inquiry

It is an API service that provides virtual account name and billing information.

12. API Virtual Account - Payment

It is an API service for Danamon VA payments/topups.

13. API Transaction Status Inquiry

It is an API service that provides transfer transaction status

14. API Virtual Account - Create VA

It is an API service to create a VA number at Danamon Bank.

15. API Virtual Account - Delete VA

It is an API service to delete VA numbers at Danamon banks.

16. API BI Fast - Credit Transfer

It is an API service that provides a feature to make transfer transactions to the recipient's account/proxy through BI Fast.

17. Proxy Alias Resolution

It is an API service that provides a feature to query proxy / alias recipient users through BI Fast.

18. FSC Direct

FSC Direct is a service where Danamon's system is directly connected to the Principal's system in terms of the Supply Chain Financing Program (Distributor or Supplier), so that business transactions between the Principal and para-Distributors/Suppliers can be carried out between Danamon accounts.

19. API Inquiry Mutation - VA Debit

It is an API service that provides certain VA Debit Number mutations.

20. API Inquiry Data - VA Debit

It is an API service that provides certain VA Debit Number registration data

21. API Balance Inquiry - VA Debit

It is an API service that provides information on certain VA debit balances.

22. API Inquiry BIN Balance - VA Debit

It is an API service that provides information on the balance of all VA debits on the registered BIN

23. VA debit update

is an API service that provides updating data on certain VA debit numbers that have been registered

24. Create VA Debit

It is an API service to register a VA debit number along with its data data.

25. Delete VA Debit

to delete a specific debit VA No that has been registered

SERVICE RISK

- Operational risks in the form of transaction failures or other non-transactional activities.
