Dear Sirs/Madams,

Berkaitan dengan *Foreign Account Tax Compliance Act (FATCA)*, dengan ini kami menginformasikan seluruh mitra keuangan sesuai dengan peraturan yang diterbitkan oleh *Internal Revenue Service (IRS)* bahwa Republik Indonesia telah mencapai kesepakatan secara substansi dengan pemerintah Amerika Serikat dan akan diperlakukan sebagai yurisdiksi dengan ketentuan IGA Model 1.


